The *University of Western Australia Law Review* publishes two issues per year. Submission deadlines are April and August respectively.

In general the acceptable length for articles is 7,000 to 10,000 words (excluding footnotes). Articles should be accompanied by an abstract of approximately 100 words. Book reviews and case notes should be no longer than 2,500 words.

All submissions should comply with the *Australian Guide to Legal Citation*.

All articles, case notes or book reviews are refereed. The submission of material for publication is taken to imply that it contains original, unpublished material and that it has not been submitted for publication elsewhere.
